4. Superintendent/President's Report:

Superintendent/President Peter Allan introduced Gary Thomas, San Bernardino County Superintendent of Schools who provided an update on the four big items occurring in public education on what is happening in public education 1) Countywide Vision, 2) Common Core State Standards (CCSS), 3) Local Control Funding Formula (LCFF); and 4) Local Control Accountability Plan (LCAP)

Academic Senate: Tracy Davis thanked Trustee Denson for her service last year as Board President and welcomed Trustee Henderson as the newly seated President. She provided an update regarding concerns as it relates to the Academic Senate which includes the need for additional counselors and full-time faculty to address student needs. The Academic Senate would like to ask the Board of Trustees to provide a more positive press as it relates to VVC. A Board policy addressing administrative evaluations is requested by the Academic Senate to provide faculty an opportunity to evaluate the administrators they work with.

Foundation: Don Brown thanked the community and media partners for their generous support. Reflections of accomplishments in 2013 included the Campaign for Classes fundraiser which raised over \$100,000 and provided classes for over 600 students. A check was presented for \$70,000 to pay for the classes that were provided. A grant for \$1.2M was awarded designed to help Community Colleges to better sever the economic and workforce development. A \$50,000 check was presented from Southern California Edison for a grant that was awarded to assist with the solar technology training program. Jaye Tashima was presented the Alumni Hall of Fame President's award for her dedicated and generous support for Victor Valley College.

Board Report: Board Members Denson, Brady, Wood and Henderson reported on the CCLC conference they recently attended in Burlingame, CA.

Ratification of the contract between Victor Valley Community College District and Helendale Chamber of Commerce Business Seminars for the delivery of a series of not-for-credit small business seminars located at 26540 Vista Road in Helendale, CA. Fiscal Impact: \$500.00, Potential revenue to the District.

5.5 Contract - Excelsior High School Aviation

Ratification of the contract between Victor Valley Community College District and Excelsior High School Aviation for the delivery of General Aviation Technology (listed as AVA 51) for credit under contract to a cohort of Excelsior high school students. Fiscal Impact: \$32,498.00, Potential revenue to the District.

5.6 <u>Agreement – Nextgen Solutions</u>

Ratification of the agreement between Victor Valley Community College District and Nextgen Solutions to provide software, setup, license and support for JobX, TimesheetX and Scholarship Manager, web-based programs for use in Financial Aid. The period of this agreement is July 1, 2013 through June 30, 2014. Fiscal Impact: \$18,000.00, budgeted item, renewable annually for three years.

Ratification of the agreement between Victor Valley Community College District and ePower Network for the emergency equipment and service provided to the District during the recent UPS (Uninterrupted Power Supply) failure, which caused power outages to the campus phones and computer network. Fiscal Impact: \$11,555.22, budgeted item.

Ratification of the agreement between Victor Valley Community College District and System Maintenance Services, Inc. to support critical infrastructure and network hardware. This amendment is to record new terms and conditions and the change from monthly payments to one annual payment. Term: 11/1/13-10/31/14. Fiscal Impact: \$6,252.00, budgeted item.

5.11 Equipment Rental - Total Environmental Management, Inc.

Ratification of the equipment rental from Total Environmental Management, Inc. to rent temporary heaters for the Construction Technology Building #65 during the bidding and construction process to replace the heater equipment permanently. Fiscal Impact: \$25,000.00, Fund 71.

5.12 Agreement – A&E Inspection Services

Ratification of the use of the three (3) year agreement between Victor Valley Community College District and A&E Inspection Services, which was originally approved by the Board April 12, 2011, to provide Inspector of Record services needed during the construction of a new parking lot across the Science Building. Fiscal Impact: Not to exceed \$7,000.00, Bond Funded.

5.13 Agreement - Paragon Tactical

Ratification of the renewal agreement between Victor Valley Community College District and Paragon Tactical to replace the power supply for the master control firing range system. Fiscal Impact: \$1,405.00, Fund 71.

5.14 Agreement - Paragon Tactical

Ratification of the renewal agreement between Victor Valley Community College District and Paragon Tactical to provide and install a commercial grade uninterruptable power supply to ensure uninterrupted operation of the Master control system and wireless signal repeaters.
