Chapter 3

District Smoking Policy AP 3570

Adopted by College Council, _____ 2017

Victor Valley College is a smoke-free institution. Smoking or the use of any tobacco products or smokeless devices such as e-cigarettes **and the smoking of marijuana as well as paraphernalia used for the smoking of marijuana** prohibited at all campus sites. Students, staff members and visitors to the campuses of Victor Valley College are permitted to use tobacco products or smokeless devices in their personal vehicles only. **The smoking of marijuana is prohibited in personal vehicles on any campus parking facilities or sites.**
