September 10	Deadline to add a 16-week classes
September 10	Last day to drop a 16-week class without receiving a “W” grade
September 11	Fall Graduation application deadline
14 days from the term start date excluding holidays	Last day to drop a 16-week length class and be eligible to apply for a refund Courses other than 16-week length classes have varied dates for refunds and “W” grades. Check your registration statement or Self Service for exact dates.
September 25	2nd 12-week classes begin (check registration statement for drop dates) Pass/No Pass grade option submission must be submitted prior to the last day of the course.
