VERIFICATION WORKSHEET DEPENDENT/INDEPENDENT STUDENT

Federal verification is a process which requires institutions to verify the accuracy of the information provided on a student's FAFSA in an effort to ensure federal aid is distributed to those who are eligible. Your FAFSA is selected for verification by the U.S. Department of Education. You are required to provide documentation to the school verifying the information you entered on your FAFSA. Reasons for being selected for verification include: your FAFSA contains estimated information or inconsistencies, was incomplete, or was selected at random. If there is a difference between your FAFSA and documentation submitted, the college will make the correction electronically.

* Victor Valley College reserves the right to request additional documentation as needed to complete this process or resolve conflicting information.

Once you complete and sign this document, upload your forms directly to your self-service portal. Incomplete, unreadable or missing documents will delay processing and awarding of financial aid. The Office of Financial Aid is a paperless office and accepts documents via your self-service portal. Emailed or faxed documents will not be accepted. Our office is happy to assist you in person with scanning your documents.
