Background: About the ACCJC Annual Report

In accordance with federal regulations and the Commission [Policy on Monitoring Institutional Performance](#), ACCJC applies a set of annual monitoring and evaluation approaches to assess member institutions' strengths, stability, and ongoing alignment with the Standards during the course of the accreditation review cycle. The Annual Report (AR) is one of the tools used for this process. Using institutions' self-reported data, the ACCJC Annual Report collects headcount information to monitor institutional growth (including growth in distance and correspondence education) and institution-set standards for key indicators of student achievement, licensure exam pass rates, and job placement rates.

Dashboards enable disaggregation by multiple students and section attributes. No reflection or storytelling is provided, a local data element dictionary provides 'tool tips' for users.

21. Reflecting on your Institution's student achievement(s), what efforts/initiatives/competencies have you found to be fundamental in supporting the recent successes you've observed/reported? Please describe any innovations and improvements along with a brief narrative of how it was achieved. (max 200 words)

We instituted an auto-award for certificate awarding and experienced great success; however, the College is amid an ERP upgrade and has resulted in several issues including having to pause the auto-award for certificates and has delayed auto-awarding for Degrees. On another note, in recent years, we have opened four engagement centers aligned with our guided pathway schools. Each of these centers have student success teams consisting of a manager, faculty counselor, faculty facilitator and peer mentors. These centers are intended to provide students with a resource of information, guidance and support. In 2021 the college implemented a call-center which we refer to as our Connect2Success center, staffed by student service specialists. The center has exceeded expectations handling over 150,000 calls per year with a caller satisfaction rate of 80-85%. The student's question is either resolved during the call or is referred to a department manager, depending upon the student's need. We have also reimagined our Caring Campus initiative in which classified staff have led the initiative to implement and apply the caring campus principles, creating an atmosphere that we must care for our students and each other if we are to make it possible for our students to succeed.

We recognize through our data analysis that a small percentage of our first-time, full-time students are attaining a degree within 3 years. We are still trying to make sense of the data and looking for the "why" but it would be helpful to hear from other colleges, maybe during an ACCJC seminar or conference from institutions that are succeeding in these efforts and how they discovered the "why", what was the "why" and strategies implemented to affect a change in a positive manner.
