Discussion: The Chair informed attendees that the Graduation Requirements Committee (GRC) requested a criterion checklist/form, driven by the changes to the competency, that may be used by another department if they believe their course fulfills the requirement for a kinesiology class. The completed form will be submitted to the Kinesiology department for review and approval before being brought before the Curriculum committee. The Chair cited FIRE 140A as an example of a course. A committee member inquired as to the definition of an area as indicated in the second asterisk of the form. The Chair clarified that an area is encompassed by the section it is in, for example activity, lecture, sports, health etc. Another committee member inquired how this would benefit the students. The Articulation Officer and Chair noted that this would enable students to utilize a course to fulfill the kinesiology competency. The committee member cited concerns of adversely affecting the department's FTES accumulation. The Chair noted the concerns and shared that a compromise was reached after this matter was brought before and approved by the Senate. Another committee member noted a potential conflict with athletics (ATHL) courses. The Chair informed the committee member that as indicated by the form, a review of instructor training is conducted during the review.
