AND THE AFT PART-TIME FACULTY UNITED, LOCAL 6286, AFL-CIO**

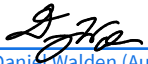
ALL COLLEGE DAY STIPEND

August 11, 2025

This Memorandum of Understanding between the Victor Valley Community College District and the AFT Part-Time Faculty United, Local 6286, AFL-CIO, is expressly made pursuant to the Educational Employment Relations Act and the parties' collective bargaining agreement. All other provisions in the Collective Bargaining Agreement shall be deemed to remain unchanged unless otherwise expressly stated.

For the 2025-2026 academic year, the District will provide a \$165.00 stipend to part-time faculty that have Fall 2025 and/or Spring 2026 contracts who attend and sign-in to the on-campus All-College Day professional development opportunities offered by the District on August 22, 2025 (morning session, 9:00 am to 12:10 p.m.) and/or February 13, 2026 (morning session, 9:00 a.m. to 12:10 p.m.).

This MOU is a temporary agreement that does not create any precedent nor establish any past practice for future bargaining purposes.
