REMINDER AND IMPORTANT INFORMATION

According to CTA Contract, all full-time faculty members in the department must receive a copy of the program review, and must be allowed one calendar week to comment, requests changes and/or approve their department's final submission.

If the simple majority of the department rejects the final version of the program review, the department chair, in consultation with the dean, shall schedule a meeting to discuss revisions, inclusions and deletions members requested. The final version of the department's program review/annual update MUST be emailed to all department members before it is formally submitted.
