#### 5. DISCUSSION ITEMS

Discussion, Information: 5.01 Other

Curriculum Committee Meeting: The Chair informed attendees of the cancellation of the October 23, 2025 meeting.

**Course Numbering:** The committee discussed a conflict between the directive to use new CCN numbers for courses launched after July 1, 2025, and the Academic Senate's approved plan to implement all new numbers in the Fall 2027 catalog. It was resolved that faculty may use legacy (old) course numbers for new or updated courses they intend to offer before the Fall 2027 semester, provided there is a justification. This allows for the timely implementation of new curriculum and urgent updates, such as updating courses so they are not removed from ASSIST.

**Prerequisite Validation:** The committee clarified that a requisite validation (disproportionate impact report) is not required for a brand-new CCN course with a new prerequisite until the course has been offered for two years, as no data is available for analysis. For an existing course converting to a CCN number, a validation must be completed for any carried-over prerequisite if one has not been performed in the last two years. The Chair reiterated the state's goal of reducing unnecessary prerequisites.
