4. EXECUTIVE OFFICER'S REPORTS

Information: 4.01 President's Report - Lee Bennett

Conversation about bot situation, has been significant improvement in limiting new, incoming bots, may not be experienced by faculty because problem is bots who were already in the system and are returning bot students. Discussions on book voucher situation, response was sent from Student Services independent consultant Mary Gallagher, information and vouchers were sent last Thursday to students and eCampus, new process is being worked out.

13 hiring committees for FT faculty in process for fall from last year's faculty hiring prioritization list, 20 FT faculty hires for spring because FON went from 134 to 169, we are being asked to put together a solid list of 30 recommendations through faculty hiring prioritization process. We need more Fair Employment Representatives for spring, training held through HR, requires shadowing on a hiring committee.

November 6 senate meeting overlaps ASCCC Fall Plenary, so we are moving the Nov meeting to third Tuesday of the month, Nov. 18.

ASEB goal for this year is revising Bylaws, Leslie is chairing the work group consisting of Patty Golder, Lisa Harvey, and Debby Blanchard.
