# 5. BOARD OF TRUSTEES: ACTION AGENDA

5.1 Memorandum of Understanding (MOU) Approval - Victor Valley Community College District & Victor Valley College District Foundation

Motion by Trustee Brady, second by Trustee Henderson, to adopt the MOU with clean up changes to the MOU as follows:

- a. Section 5.5.1, which references section 5.1.1 parenthetically—5.1.1 should be changed to 5.3.
- b. Section 5.5.3, which references section 5.1.1 parenthetically—5.1.1 should be changed to 5.4.1.
- c. Delete sections 5.5.4, 5.5.5, and 5.5.6, as they are duplicates of 5.5.1, 5.5.2, and 5.5.3 respectively.

Trustee Brady withdraws the portion of the motion above to adopt the MOU only and moves the above amendments correcting the MOU document. Trustee Henderson agrees with the withdrawal of the motion to adopt the MOU and seconds the motion to amend the MOU as stated above. The stated motion to amend passed 5-0.

Motion by Trustee Brady, second by Trustee Henderson, insert a new section 3.2.6, and existing section 3.2.6 of the MOU will become section 3.2.7. The new section 3.2.6 will charge the Foundation a rental rate of \$.56 a square foot. The square footage is to be confirmed and inserted into the MOU. The rent is to be paid in cash or in kind. The rental rate of \$.56 a square foot is below market value. The motion passed 5-0.

Motion by Trustee Wood, second by Trustee Brady, to add to the new section 3.2.6, that the Governing Board of the Victor Valley Community College District recognizes that the Victor Valley College Foundation existed prior to August 31, 1980, and has a formal relationship with and works on behalf of and solely for the Victor Valley Community College District. The motion passed 5-0.

Motion by Trustee Brady, second by Trustee Wood, to adopt the MOU as amended. The motion passed 5-0.

Board President Tortorici stated that the MOU will be brought back to the board with all changes/amendments/and deletions. This is just a portion of the MOU.
