



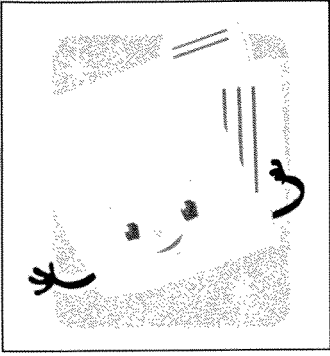

1. Approval of the Minutes

2. Accreditation
